TERMS
<p>PAYMENT Delivery of payment is due upon receipt, within 15 days of the invoice date.</p> <p>LATE FEES Overdue invoices are subject to a 10% fee, compounded at 10% for each additional month.</p> <p>CANCELLATIONS 100% kill fee if canceled within 24 hours / 50% kill fee if canceled within 48 hours. Kill fee includes kit rental. Any outsourced rentals will incur a full charge from vendors.</p> <p>FORCED CALL Forced Calls will be charged at \$100/incident when the rest period is less than 12 hours between set departure and call.</p> <p>TESTING Any testing required on a non-work day will be charged a \$250 stipend plus any testing fees.</p> <p>MILEAGE Charged when the location is 30 miles or more (one-way), for any travel after the call and on distant-hire or travel terms.</p> <p>EQUIPMENT INSURANCE Certificate of Insurance (C.O.I.) with general liability and Rented Equipment Coverage must be issued by production, listing High Ground Sound as Additional Insured and Loss Payee. L&D Production assumes responsibility for any lost or damaged items during the term of the shoot. Production is responsible for paying the insurance deductible.</p> <p>MEAL BREAKS Meal breaks are required every 6 hours. Adequate meals must be provided for breaks under 1 hour. Fast food, pizza, and low-quality foods will not be considered meals and will be subject to penalties and, when operating on travel terms below, per diems.</p> <p>MEAL PENALTY Charged 1 hour straight-time for each 30-minute increment until a meal is taken.</p> <p>STORAGE Files will be stored for a minimum of three months, up to a year upon request and for a fee.</p> <p>COPYRIGHT Recordings are the copyright of High Ground Sound (HGS) until all invoices, fees, and payments are paid in full. This includes but is not limited to labor, equipment, fees, L&D, expendables, and reimbursements. HGS reserves the right to withhold recordings until payment is received. Following full payment, copyrights become the property of the Client. HGS reserves the right to use audio for obtaining future employment when it does not infringe upon any Non-Disclosure Agreements.</p> <p>TRAVEL, LODGING & PER DIEM When a location is beyond 60 miles, Production is required to provide lodging, per diem, and portal-to-portal mileage and hours for the length of the stay. When the contractor deems it unsafe to travel due to extensive hours or distant locations, Production is required to pay for lodging and/or transportation. For any days that lodging is provided continuously in excess of one day, Production will provide Per Diem, Portal-to-Portal, and cover all lodging and travel expenses. Production is responsible for all expenses (baggage, visas, carnets, etc).</p> <p>COVERED CREW The above Rates & Terms apply to all High Ground Sound personnel hired and under HGS direct supervision, including but not limited to Production Mixer, Boom Operator, Sound Utility, A2, and Audio Assistants.</p> <p>ACKNOWLEDGEMENT Delivery and receipt of this Rate Card indicate the Production Company's acceptance of the Rates and Terms listed herein unless otherwise documented in writing between the Production Company and High Ground Sound.</p>
